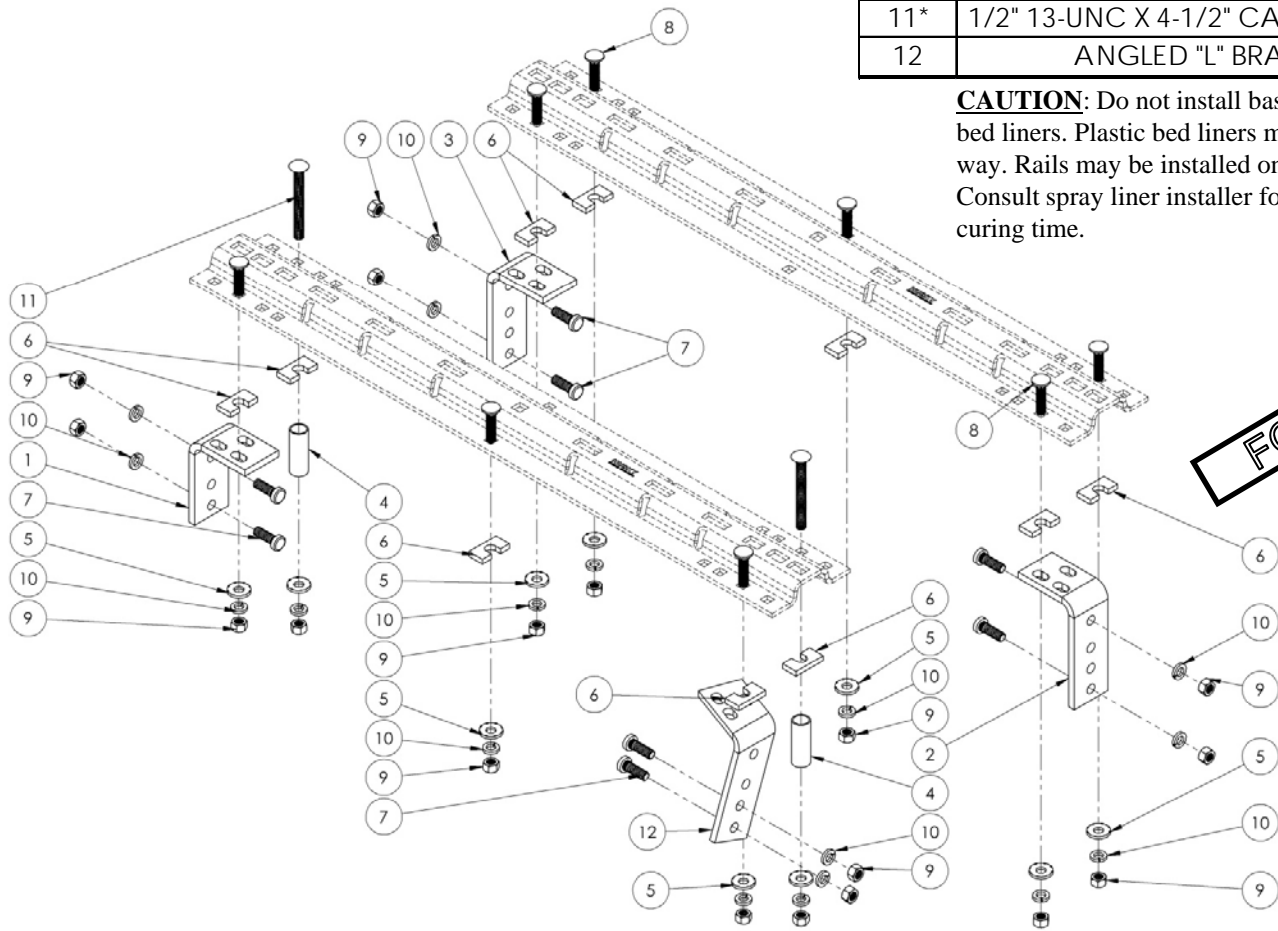
- Sockets/Wrenches: 3/4"

- Center Punch.
- Tape Measure.
- 75 lbs-ft min. Torque Wrench.
- Torque 1/2" nuts to 75 lbs.-ft.

WARNING! Never exceed the towing capacity of the tow vehicle.

Center Bolt Kit 32059 (sold separately) must be used when towing with a 26K hitch, Goose Neck, or Maneuvering System.

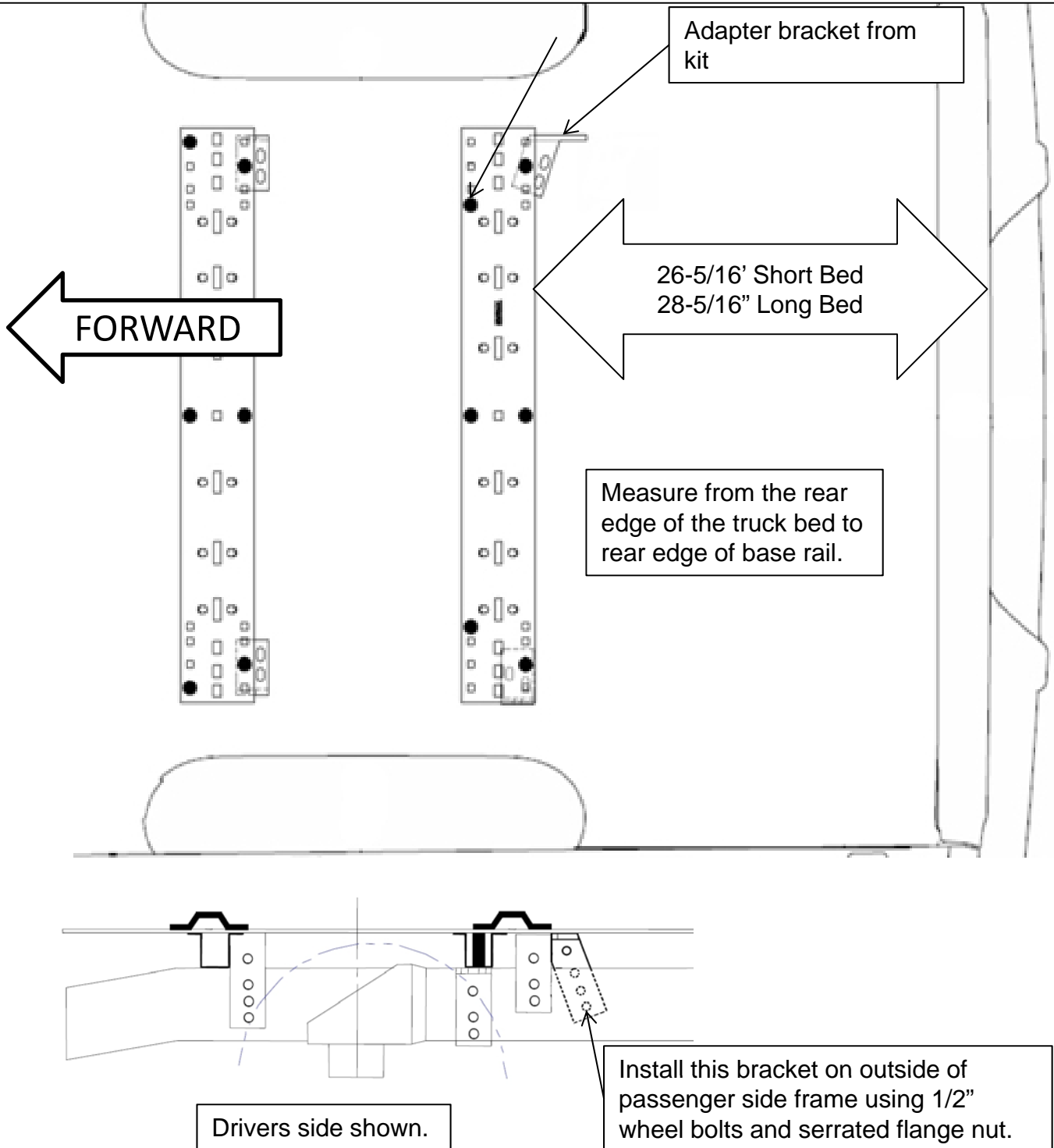


CAUTION: Do not install base rails over plastic bed liners. Plastic bed liners must be cut out of the way. Rails may be installed on spray in liners. Consult spray liner installer for recommended curing time.



This adapter kit is to be used with install kit 31622 "Fit #10". This means omitting the passenger side rear bracket and installing a bushing and carriage head bolt the same as on the driver side rear is. Then install the bracket from this kit as shown below.

Mark center of this hole in the base rail and then move rail out of the way and drill a $17/32$ " hole into the bed and completely through the bottom of the "Hat Channel/Sill Assembly". **BEFORE DRILLING**, ensure there are no components under the bed. Then open up the hole in the bed with a 1" diameter drill. Drop tube spacer through hole in bed, replace rail and insert carriage head bolt and finish by adding the washers and nut from the underside and torque all $1/2$ "-13 nuts to 75 ft-lbs.
